

SGS has been contracted by Prosperity Dielectrics Co.Ltd. (hereinafter referred to as "PDC"), 566-1, Kao-Shi Road, Yang-Mei Dist., Taoyuan City, Taiwan (R.O.C) for the verification of direct and indirect Greenhouse Gas emissions in accordance with

ISO 14064-3:2006

as provided by Prosperity Dielectrics Co.Ltd. (hereinafter referred to as "PDC"), 566-1, Kao-Shi Road, Yang-Mei Dist., Taoyuan City, Taiwan (R.O.C), in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2020 to 31 December 2020.

Roles and responsibilities

The management of PDC is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the period 01 January 2020 to 31 December 2020.

SGS conducted a third party verification of the provided GHG assertion against the principles of ISO 14064-1:2018, ISO 14064-3:2006 in the period 02 Dec 2021 to 15 Dec 2021. The verification was based on the verification scope, objectives and criteria as agreed between PDC and SGS on 14 July 2021.

Level of Assurance

The level of assurance for category 1 and category 2 agreed is that of reasonable assurance.

Scope

PDC has commissioned an independent verification by SGS Taiwan of reported GHG emissions of PDC arising from Electronic component manufacturing activities, to establish conformance with ISO 14064:2018 principles within the scope of the verification as outlined below.

This engagement covers verification of emission from anthropogenic sources of greenhouse gases included within the organization's boundary and is based on ISO 14064-3:2006.

Objective

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the GHG emissions are as declared by the organization's GHG assertion
- The data reported are accurate, complete, consistent, transparent and free of material error or omission.

Criteria

Criteria against which the verification assessment is undertaken are the principles of ISO 14064-1:2018.

Materiality

The materiality required of the verification was considered by SGS to 5%, based on the needs of the intended user of the GHG Assertion.

Conclusion

PDC provided the GHG assertion based on the requirements of ISO14064-1: 2018. The GHG information for the period 01 January 2020 to 31 December 2020 disclosing emissions of 44,337.891 metric tonnes of CO₂ equivalent and 0.0000 metric tonnes of direct CO₂ emissions from the combustion of biomass are verified by SGS to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria.

We conducted our verification with regard to the GHG assertion of PDC which included assessment of GHG information system, monitoring and reporting plan/protocol. This assessment included the collection of evidence supporting the reported data, and checking whether the provisions of the protocol reference, were consistently and appropriately applied.

In SGS's opinion the presented GHG assertion

- is materially correct and is a fair representation of the GHG data and information, and
- is prepared in accordance with ISO14064-1:2018 on GHG quantification, monitoring and reporting.
